How to Use the Copyright Clearance Center: What Every Faculty Member Needs to Know About Copyright Law: The Alamo Colleges subscribe to the Annual Copyright License (ACL) through the Copyright Clearance Center (CCC). The CCC will conduct an informational session on how copyright law is affecting the way faculty, staff, students and other content-users share information. In addition, they will provide training on how to use the ACL as a valuable resource to support the free flow of information while respecting the intellectual property of others.

Family Medical Leave Act Policy Training: The Family and Medical Leave Act (FMLA) requires covered employers to provide up to 12 weeks of unpaid, job-protected leave to eligible employees for certain family and medical reasons.
