Government 2305 – American Government

#1 Student Learning Outcome:

Students will demonstrate knowledge of the institutional processes that lead to governmental action, i.e, legislation and policy implementation, and how these institutions work with each other constitutionally and politically.

Assessment Measure for this Outcome:

Instructors choose 3 specific questions from a question bank addressing this outcome on the final exam across all sections that address this outcome.

Achievement Target for this Measure:

70% of students enrolled in Govt. 2305 will successfully answer selected questions from the above list.

Findings:

For the Spring, 2010 semester, the final exams administered by both Oliver Jones and Ginny Stowitts Traina were used as pilots. The results were:

Question #1 - 88.7% of the students successfully answered this question. (47 out of 53) Question #2 - 96.2% of the students successfully answered this question. (51 out of 53) Question #3 - 66.0% of the students successfully answered this question. (35 out of 53) Question #6 - 83.8% of the students successfully answered this question. (67 out of 80) Question #7 - 71.0% of the students successfully answered this question. (57 out of 80) Question #8 - 78.8% of the students successfully answered this question. (63 out of 80) Question #9 - 67.5% of the student successfully answered this question. (54 out of 80) Question #10 - 71.0% of the student successfully answered this question. (57 out of 80)

Consequently, an average of 77.9% of students taking the finals for Oliver Jones and Ginny Stowitts Traina successfully answered these questions.

Question #1 - 37.7% of the students successfully answered this question. (20 out of 53) Question #2 - 94.3% of the students successfully answered this question. (50 out of 53) Question #4 - 71.0% of the students successfully answered this question. (57 out of 80) Question #5 - 60.0% of the students successfully answered this question. (48 out of 80) Question #6 - 53.0% of the students successfully answered this question. (53 out of 80)

Consequently, an average of 63.2% of students taking the finals for Oliver Jones and Ginny Stowitts Traina successfully answered these questions.

For the Spring, 2010 semester, the final exams administered by both Oliver Jones and Ginny Stowitts Traina were used as pilots. The results were:

Question #1 - 81.1% of the students successfully answered this question. (43 out of 53) Question #2 - 75.5% of the students successfully answered this question. (40 out of 53) Question #4 - 80.0% of the students successfully answered this question. (64 out of 80) Question #5 - 71.0% of the students successfully answered this question. (57 out of 80) Question #6 - 71.0% of the students successfully answered this question. (57 out of 80) Question #7 - 83.8% of the students successfully answered this question. (67 out of 80)

Consequently, an average of 77.1% of students taking the finals for Oliver Jones and Ginny Stowitts Traina successfully answered these questions.

Question #1 - 66.1% of the students successfully answered this question. (35 out of 53) Question #2 - 83.0% of the students successfully answered this question. (44 out of 53) Question #4 - 73.8% of the students successfully answered this question. (59 out of 80) Question #5 - 75.0% of the students successfully answered this question. (60 out of 80) Question #6 - 72.5% of the students successfully answered this question. (58 out of 80) Question #7 - 67.5% of the students successfully answered this question. (54 out of 80) Question #8 - 66.3% of the student successfully answered this question. (53 out of 80)

Consequently, an average of 72.0% of students taking the finals for Oliver Jones and Ginny Stowitts Traina successfully answered these questions.

Government 2306 – Texas Government

#1 Student Learning Outcome:

Achievement Target for this Measure:

70% of students enrolled in Govt. 2306 will successfully answer the selected questions.

Findings:

For the Spring, 2010 semester, the final exams administered by Oliver Jones was used as a pilot. The results were:

Question #1 - 91.0% of the student successfully answered this question. (82 out of 90) Question #2 - 22.2% of the students successfully answered this question. (20 out of 90)

Overall, 56.6% of the students successfully answered the questions. After discussion with Mr. Jones, it was agreed that the problem with question #2 was that it is ambiguously written. This might have led to the poor showing on this question.

Question #6 - 46.7% of the students successfully answered this question. (42 out of 90) Question #7 - 94.4% of the students successfully answered this question. (85 out of 90)

Overall, 70.6% of the students successfully answered the questions.
